7. TO RESOLVE ON AN AMENDMENT TO THE STANDING ORDERS TO REMOVE STANDING ORDER 1(M) REGARDING RECORDING THE PROCEEDINGS OF **PARISH COUNCIL MEETINGS**

Following advice from GAPTC it was resolved to amend Section 1M of Pauntley Parish Council's Standing Orders to reflect the new rules regarding recording proceedings of parish council meetings. The Clerk will amend these accordingly.

TO CONSIDER AND RESOLVE ON WHETHER TO RE-INVESTIGATE THE 8. POSSIBILITY OF A SPEED LIMIT THROUGH PARTS OF THE PARISH

A previous approach to Gloucestershire Highways some years ago for a speed limit through the parish had been unsuccessful, mainly due to the view that the density of housing was not sufficient and that it would not be possible to enforce this. It was felt that the increase in traffic

(including delivery vans and agricultural traffic) and horse riders, and the number of accidents and near-misses (which are not reported to the police), a further attempt should be made, particularly since there is a primary school on the main road through Pool Hill. The Clerk will investigate this again.
