# PAUNTLEY PARISH COUNCIL GRANTS AND DONATIONS POLICY

# Adopted:

## To be reviewed every 4 years

This policy outlines the way grants and donations (hereafter referred to as 'grants') requested by outside bodies are treated. It does not cover grants made by the Parish Council on its own initiative.

The Parish Council has a small budget for the award of grants. The maximum sum set aside each financial year for grants is to be recommended annually by the Finance Working Group and agreed annually at the full Parish Council meeting in which the precept is set. The aim of the grant scheme is to provide an opportunity for financial support to community organisations that benefit the Parish of Pauntley who would be unable to continue without such support. The objective is to provide services and facilities to the residents and area of Pauntley Parish which will enhance quality of life.

Pauntley Parish Council awards grants, at its discretion, to organisations which can demonstrate a clear need for financial support to achieve an objective which will benefit the Parish by:

- providing a service
- enhancing the quality of life
- improving the environment
- promoting the Parish of Pauntley in a positive way

#### It will not award grants to:

- Private individuals
- Commercial organisations
- Grants will not be awarded to fund activities of a political nature, nor activities considered to be the responsibility of the principal authority.
- Grants will not be awarded to organisations that make, or attempt to make, profit for the benefit of members or owners over and above revenue expenditure, e.g. running costs, staff costs, premises maintenance and general overheads.
- Political parties
- Religious organisations, unless for a purpose which does not discriminate on grounds of belief
- Grants will not be made retrospectively.

#### **Conditions and criteria for funding:**

- 1. Applications must be made in writing and submitted to the Clerk, together with appropriate accounts, supporting financial information, recent bank statement or evidenced projected costings, if available.
- 2. All applications will be considered on their merits but in general, grants will be awarded for specific projects or events.
- 3. The purpose for which the grant is made must be in the interest of Pauntley Parish.

- 4. Groups from outside the Parish can apply for a grant but must be able to demonstrate direct benefit to the area and the residents of Pauntley Parish.
- 5. The Parish Council will take into account any previous grant made to an organisation or group when considering a new application.
- 6. The amount of the grant will be at the discretion of the Parish Council.
- 7. Payments for grants will not be paid to individuals unless under exceptional circumstances and only when eligible to do so under the General Power of Competence.
- 8. All applicants receiving a grant must provide an End of Project Report, including a breakdown of expenditure, together with (copy) receipts within 3 months of the project completion. (Unless agreed otherwise, projects should be completed within 1 year of a grant offer).
- 9. If the grant is put to purposes other than those for which it was awarded without the prior approval of the Parish Council, the recipient organisation will be required to repay the grant to the Parish Council.
- 10. Applications will not be considered from organisations as identified above.
- 11. Organisations applying for a grant should normally be properly constituted, with appointed officers.
- 12. Grants will be awarded on the assumption that other sources of income have been considered.
- 13. Only one grant will be considered for an organisation during the year unless there are exceptional circumstances.
- 14. The Parish Council reserves the right to refuse any grant application which they consider to be inappropriate or against the objectives of the Parish Council.
- 15. If the organisation / body is unable to use the grant for the stated purpose, monies must be returned to Pauntley Parish Council.

#### How will the application be assessed?

- 1. How well the grant will meet the needs of the community, providing positive benefit to the inhabitants.
- 2. How effectively the group will use the grant.
- 3. Whether the costs are appropriate and realistic.
- 4. What level of contributions has been, or will be, raised in addition to the grant.

#### General:

- Grant applications will be considered by the Full Parish Council.
- If grant requests received exceed the grant monies available in a financial year, then councillors will target projects/donations which benefit as many people as possible within the parish.
- Applicants should not assume that a grant will be awarded by Pauntley Parish Council each year and should not be relied upon.
